1. Regular Meeting – January 3, 2023

CONSENT AGENDA

1. Approval for Sergeant Greg Jones, Officer Beau Dickson and Officer Matthew Brown to attend a Mississippi Law Enforcement Officer's Association K-9 Seminar/Training and Certification in Tupelo, Mississippi on March 14-16, 2023.
