ADJOURNED MEETING

SEPTEMBER 25, 2023

Pursuant to the adjournment taken, September 19, 2023, the Mayor and Board of Alderman of the City of Batesville reconvened at 10:00 a.m., on September 25, 2023, at the City Hall, 103 College Street, Batesville, Mississippi, when and where were present the following, to-wit: Mayor Hal Ferrell; Aldermen Dennis Land, Stan Harrison, Teddy Morrow and Bill Dugger. Also present were: City Clerk Susan Berryhill; Chief of Police Kerry Pittman; Assistant Chief of Police George Williford; Public Works Director David Karr; Assistant Public Works Director Newt Benson; Parks and Recreation Director Heath Fullilove; Assistant City Clerk Shannah Weaver and Jeremy Weldon of The Panolian.

Also present was Joe Azar.

A quorum being present, the meeting was duly opened by the Mayor, and after the invocation given by Josh Hawkins, the following business was taken up.

IN RE: ORDINANCE – CURFEW

Upon motion of Alderman Harrison and second of Alderman Land and upon unanimous vote taken, the following Ordinance was adopted:

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF BATESVILLE, MISSISSIPPI, ESTABLISHING A CURFEW FOR PERSONS OF THE AGE OF SEVENTEEN YEARS AND YOUNGER

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Batesville, Mississippi, that:

Section 1. ***Definitions.***

The following words and phrases have the following meanings in this Ordinance:

“Child” and “Children” mean a person or persons seventeen (17) years old and younger.

“Guardian” means the parents of a child and any other person with whom a child lives.

“Time of curfew” means from eleven o’clock p.m. (11:00 p.m.) on Sunday until six o’clock a.m. (6:00 a.m.) the following Monday, from eleven o’clock p.m. (11:00 p.m.) Monday until six o’clock a.m. (6:00 a.m.) the following Tuesday, from eleven o’clock p.m. (11:00 p.m.) Tuesday until six o’clock a.m. (6:00 a.m.) the following Wednesday, from eleven o’clock p.m. (11:00 p.m.) Wednesday until six o’clock a.m. (6:00 a.m.) the following Thursday, and from eleven o’clock p.m. (11:00 p.m.) Thursday until six o’clock a.m. (6:00 a.m.) on the following Friday, and from twelve o’clock a.m. (12:00 a.m.) Saturday until six o’clock a.m. (6:00 a.m.) Saturday, and from twelve o’clock a.m. Sunday (12:00 a.m.) until six o’clock a.m. (6:00 a.m.) Sunday.

“Child’s residence means the place where the child permanently lives with a parent or guardian and the place where the child is temporarily visiting as an overnight guest.

Section 2. ***Curfew.***

- (1) During the time of curfew, a child shall not be absent from the child’s residence. During the time of curfew, a guardian shall not allow the guardian’s child to be absent from the child’s residence.

(2) This curfew shall not apply to a child who is (a) going to, attending, and going to the child's residence immediately following the conclusion of lawful and peaceful entertainment events and political events, (b) going to, attending, and going to the child's residence immediately following the conclusion of an event held or sponsored by a school or a religious organization, (b) going to, attending, and going to the child's residence immediately following the conclusion of similar events that are lawful and being held and occurring lawfully and peacefully and attended by or supervised by persons twenty-one (21) years of age and older, (c) seeking medical attention, (d) in the company of the child's guardian, and (e) going to work and going to the child's residence immediately following the conclusion of work.

Section 3. ***Penalty for Violation.***

Any child or guardian violating the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction shall be fined \$250.00 for the first violation; \$ 500.00 for the second violation; and \$750.00 for the third violation along with the incarceration of the guardian for three days. Conviction includes the judgment of the court, a guilty plea and plea of *nolo contendere*.

Section 4. ***Effective upon adoption.***

This ordinance is being adopted for the immediate and temporary preservation of the public peace, health, and safety; and for the permanent preservation of the public peace, health, safety, and good order and peace of the City of Batesville; and for the protection of children from harm and injury. Upon the adoption of this ordinance by the unanimous vote of all the aldermen this ordinance shall be effective from and after the date of its adoption.

ORDAINED, APPROVED AND ADOPTED at a regular meeting of the Mayor and Board of Aldermen on this the 26th day of September 2023.

In order for Charles to be considered, the following must be disclosed and agreed to.

The City can employ Charles Wright's company to handle the credit card matters, if and only if, the following conditions are met:

1. Full disclosure to the City of Batesville aldermen announced to the city board on 9/25/2023; a copy of this statement filed with the city clerk.
2. I have no direct, or indirect interest, in Charles' employment or his company.
3. There is total and complete financial independence between Charles/Natalie (Ferrell) Wright and me.
4. I will totally and completely recuse myself from all phases of employing the company, and if employed, from approving the payment of or any pecuniary benefits to his company or Charles Wright.
