**IN RE: RESIDENCY OF ALDERMAN AT LARGE**

On motion made by Alderman Land and seconded by Alderman Harrison and unanimously carried upon a vote being taken thereon it is hereby ordered by the Mayor and Board of Aldermen of the City of Batesville, Mississippi [“Mayor and Board”] as follows.

The Mayor and Board have investigated the allegations made by the writer of an anonymous letter that Alderman Teddy Morrow has removed his residence from the City of Batesville and thereby vacated his office of Alderman at Large citing Section 21-3-11 of the Mississippi Code of 1972.

The Mayor and Board find and determine that although Alderman Morrow has sold his home at 209 Craig Street in the City of Batesville, his intentions are, and have been, to build a new home in the City of Batesville and he has taken the preliminary steps to do so including, but not limited to, obtaining house plans, acquiring a lot in the City, and commencing dirt work on the lot; that he is currently and has been continuously domiciled in the City for over thirty two (32) years and intends to remain domiciled in the City; that he has not abandoned his domicile in the City nor has he established a new domicile outside the City; and he is, and intends to remain, domiciled in and a resident of the City.

Accordingly, the Mayor and Board orders and adjudicates that Alderman Teddy Morrow is now, and has been continuously for over thirty-two (32) years, a resident of the City of Batesville and has not removed his residence from, or removed out of, the City of Batesville, and is the duly qualified, elected, and serving Alderman at Large for the City of Batesville, Mississippi.
