Upon motion of Alderman Morrow and second of Alderman Harrison and upon the following votes taken: Alderman Dugger – aye; Alderman Walton – aye; Alderman Land – aye; Alderman Harrison – aye; Alderman Morrow – aye, the following Ordinance was adopted:

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF BATESVILLE, MISSISSIPPI, AMENDING SECTION 10-52 OF THE CODE OF ORDINANCE OF THE CITY OF BATESVILLE, MISSISSIPPI

BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Batesville, Mississippi as follows:

1.

That Section 10-52 of the Code of Ordinance of the City of Batesville, Mississippi, is hereby amended to read as follows. No person shall operate or place an eighteen-wheeler or any vehicle weighing in excess of ten thousand (10,000) pounds on the following roadways: Keating Road, Woodland Road, House – Carlson Drive and that part of Pine Lodge Road that generally runs North and South and generally parallel to Interstate 55. A violation of this section shall be a misdemeanor and upon conviction of any person for such violation, such person shall be fined \$1,000.00 and /or be sentenced up to ninety (90) days in jail.

2.

That House - Carlson Drive and that part of Pine Lodge Road that runs generally North and South and generally parallel to Interstate 55 currently are being damaged by such trucks and in order to stop the damage, avoid costly repairs, and mitigate such damages and repairs this Ordinance shall take effect immediately from and after its passing by a unanimous vote of all Alderman of the City of Batesville, Mississippi.
